Access to the Conference will be assured through the issuance of specific badges. Your entire delegation will receive nominal passes which provide access to the Palais des Nations and the general area of the Conference.

Access to the Council Chamber will be restricted. For this purpose, we are also issuing secondary non-nominal badges which you can assign, as appropriate, to specific members of your delegation. Each Guarantor will have twenty seats in the Council Chamber. Nominal and secondary badges can be picked up at Pregny Gate at your convenience.

In the Council Chamber, your Head of delegation will have a seat at the main table with the Secretary-General. Two additional seats are assigned to your delegation at this table.
